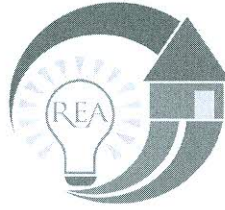

- **Dual pricing** in terms of Statutory Instrument (S.I) 185 of 2020-Bidders must quote their prices both in USD and the RTGS currency using the prevailing exchange rate.
- Bidders must state the exchange rate used. Attach proof from the bank without fail.
- Bids that use a nonexistent exchange rate shall be rejected as non-compliant.
- Payment shall be strictly in local currency at the prevailing exchange rate.
- The ZWS prices shall be used for purposes of tender evaluation.
- Bidders **MUST** state clearly whether they charge VAT or not.

The quotation must provide the following information/Attachments.

- ✓ Bid Price as per format above.
- ✓ Payment terms **must be clearly STATED**(Our preferred terms are **14 days after delivery**)
- ✓ Indicate price validity (**must be STATED in days**) (at least 14 Days)



- ✓ Delivery period from date of official order (**must be clearly STATED**)
- ✓ **Copy of a valid Tax Clearance Certificate from Zimbabwe Revenue Authority**
- ✓ Copy of the Certificate of Incorporation
- ✓ **Attach proof of registration with Procurement Regulatory of Zimbabwe (PRAZ) with the relevant category. All suppliers to REF must be registered with PRAZ in terms of the law.**
