In terms of section 41(4) of the Public Procurement and Disposal of Public Assets Act (22:23), the Rural Electrification Fund (REF) reserves the right to amend the bidding document at any time before tender closing. These amendments/clarifications shall be used for purposes of tender evaluation.

Bidders are advised that REF has amended the tender requirements. The new requirements for the tender are as follows:

Bidders are also advised that for purposes of this tender, Joint Ventures will not be accepted. Also take note that The Domestic preference rule as provided on clause (e) of the evaluation criteria shall apply to Lot 1 only.

ISO certification-Bidders interested in Lot 1 MUST attach an ISO certificate in the name of the bidder while bidders interested in the remaining Lots must attach proof of ISO certification from the manufacturer of the cables. Therefore bidders are free to import the cable on Lots 2-4.
